### **NER-AMTA General Membership Meeting**

Hotel Viking, Newport Rhode Island

Friday, March 8, 2023

President Wendy Krueger called the meeting to order at 8:17 a.m.

#### **1. Welcome & Introductions**

Wendy opened the meeting by leading attendees in singing “Here Comes the Sun.”

#### **2. Indigenous Land Acknowledgment**

Wendy acknowledged the space and territories on which the conference is held. The Hotel Viking and surrounding communities are located within the traditional territory of the Narragansett Nation and the Niantic (Nehantic) People. We express gratitude for them and all Indigenous Peoples for their continuous presence and stewardship of the land.

#### **3. Approval of Meeting Minutes**

Jean Nemeth made a motion to approve the minutes from the October 26, 2023 NER-AMTA fall business meeting. Cathy Kang seconded the motion. After a successful vote, the minutes were approved as presented.

#### **5. Conference Update**

Vice President Mary Reinsch and Vice President-Elect Emily Hawley welcomed attendees to this year’s conference, “Harmonizing Communities Across Generations.” They encouraged attendees to share feedback, concerns, and any support needs. This year, there are 28 concurrent sessions and 7 CMTEs. There are 181 attendees with at least 40 student registrants. There are 6 vendors and 2 sponsors. Thank you to our Gold Tier Sponsor, Roman Music Therapy Services. Thank our Bronze Tier Sponsor, Berklee College of Music. Attendees can find the attendance certificate located on the final page of the PDF conference program. Printed copies will also be available at the registration desk.

Updates will be forthcoming regarding the 2025 regional conference. Based on feedback from the last conference, the board is actively working to finding a location that is more accessible to attendees.

#### **6. Committee Updates and Reports**

**Professional Advocacy Committee:** Lyzz Zinn reported that the committee is evaluating representations of music therapy in different media sources and in the public. The committee compiles misrepresentation, advocacy reports, and track sources of misrepresentation. Lyzz encouraged members to contact the committee about these instances via email or Facebook. They are currently looking for people to help create elevator speeches about music therapy. There is a form for this if you are interested. If you have any ideas or anything you would like to see the professional advocacy committee do, please contact them!

**Membership Committee:** Ali Iaria reported the AMTA has rolled out the new tiered membership structure. The committee is looking at other memberships to see what benefits they offer to members. Contact the membership committee if you have ideas about what you would like to see out of membership.

**Academic Program Approval Committee:** Heather Wagner submitted the following report:

The Academic Program Approval Committee (APAC) has, as its primary task, to approve new programs and re-approve academic programs. Our committee work is year-round, so we are meeting throughout the year to better address ongoing needs and issues that have arisen with higher demand for new music therapy programs around the country.

In 2023 and early 2024, the following new programs were approved.

Cleveland State University (OH) – BS (Bachelor of Science in Music Therapy)

Louisiana State University – BMT (Bachelor of Music Therapy)

Truman University (Kirksville, MO) – BS (Bachelor of Science in Music Therapy)

St. Cloud State University (MN)– BS (Bachelor of Science in Music Therapy)

We also have 16 reviews currently in process. Those include 6 new program applications, a few 10-year re-approval applications, 3-year status updates for new programs, and a couple of programs that are making substantive changes such as moving to a distance format and/or re-structuring the music therapy curriculum. For many reasons, including the restructuring of AMTA, and the overturn of committee leadership last year, we have a backlog of applications, and are expecting at least 30 more reviews to be coming in this year. So, this is a wildly busy group of volunteers! Another focus for our committee is to review the AMTA Standards of Education and Clinical Training to assure that they represent the current state of education. Related to that, the Committee presented, at the 2023 AMTA Symposium, on the AMTA University Affiliated Internship Guidelines that were approved by the AMTA Assembly of Delegates and published in 2021. This presentation detailed the role of all parties involved in the University Affiliated Internship process, the Academic Supervisor, the On-Site Supervisor, and the Student. Internally, the Committee has been working to revise all of the program applications, to streamline the information submitted, and make the review process smoother for everyone involved now that we have moved to a completely digital format for application submission and review. The Policies and Procedures document of the Committee is also undergoing a major revision and should

be ready for distribution shortly. This Committee works with a representative from each region and also has 6 At-Large members appointed by the AMTA Board of Directors. We are currently looking for a member from the Western Region. Our committee members include:

### **8. Music Therapy in Rhode Island**

Nicole O'Malley provided background about the progression of music therapy in Rhode Island over the past 20 years. Nicole started with one client in 2003, growing to 3 clients in 2024, 85 in 2008, and 4681 clients in 2021. Rhode Island music therapy licensure passed in 2014. Music therapists in Rhode Island are now recognized as level II providers, licensed through the Rhode Island Department of Health (and collaborate with RIDOH for arts-based initiatives), and provide music therapy to major hospitals in Rhode Island. In Newport, music therapists provide services in local schools, have a grant for substance exposed newborns, and are supporting a developing program at Newport Hospital. Music therapists in Rhode Island continue to advocate and advance the field of music therapy for the benefit of clients throughout the state.

### **9. NER-AMTAS/SAAB Update**

NER-AMTAS Alayah Tedder gave a yearly overview of what the student board has done. Passages was held on October 28, 2023 with the theme of "Roses, Buds, and Thorns." They had about 40 registrants and 10 keynote presentations.

The Spring Event 2024 was held a few weeks ago at Westfield State University. The theme was the butterfly effect and how we each have an impact on each other in music therapy. Twenty-four people registered for this event.
